DUE TO THE CONTINUING DROUGHT CONDITIONS THE CITY OF CUMBY IS CONTINUING THE **STAGE 1 (MILD WATER SHORTAGE CONDITIONS)** OF OUR DROUGHT CONTINGENCY PLAN / WATER RESTRICTING.

**STAGE 1: WATER USE RESTRICTIONS.** UNDER THREAT OF PENALTY FOR VIOLATION, THE FOLLOWING WATER USE RESTRICTIONS SHALL APPLY TO ALL PERSONS

**STAGE 1 RESPONSE – MILD WATER SHORTAGE CONDITIONS**

**GOAL: ACHIEVE A VOLUNTARY 20% REDUCTION IN THE DAILY AVERAGE TOTAL WATER DEMAND.**

**SUPPLY MANAGEMENT MEASURES:** REDUCE OR DISCONTINUE FLUSHING OF WATER MAINS AND FIRE HYDRANTS.

**VOLUNTARY WATER USE RESTRICTIONS:**

**(a) CUSTOMERS ARE REQUESTED TO VOLUNTARILY LIMIT THE IRRIGATION OF LANDSCAPED AREAS TO SUNDAYS AND THURSDAYS FOR CUSTOMERS WITH A STREET ADDRESS ENDING IN AN EVEN NUMBER (0,2,4,6,8) AND SATURDAYS AND WEDNESDAYS FOR WATER CUSTOMERS WITH A STREET ADDRESS ENDING IN AN ODD NUMBER (1,3,5,7,9), AND TO IRRIGATE LANDSCAPES ONLY BETWEEN THE HOURS OF 8:00 P.M. TO MIDNIGHT (12:00 A.M.) AND 6:00 A.M. to 9:00 P.M. ON DESIGNATED WATERING DAYS.**

**(b) ALL OPERATIONS OF THE CITY OF CUMBY SHALL ADHERE TO WATER USE RESTRICTIONS PRESCRIBED FOR STAGE 2 OF THE PLAN.**

**(c) WATER CUSTOMERS ARE REQUESTED TO PRACTICE WATER CONSERVATIONS AND TO MINIMIZE OR DISCONTINUE WATER USE FOR NON-ESSENTIAL PURPOSES.**

**ANY PERSON WHO VIOLATES THIS PLAN IS GUILTY OF A MISDEMEANOR AND, UPON CONVICTION SHALL BE PUNISHED BY A FINE OF NOT LESS THAN \$100.00 AND NOT MORE THAN \$200.00. EACH DAY THAT ONE OR MORE OF THE PROVISIONS IN THIS PLAN IS VIOLATED SHALL CONSTITUTE A SEPARATE OFFENSE.**

**YOU WILL BE NOTIFIED WHEN THIS RESTRICTION IS LIFTED.**
