An additional charge will be filed against you for violation of promise to appear and warrants issued.**

**CONTACT THE COURT FOR ADDITIONAL FINES NOT LISTED ABOVE. FINES WILL BE DOUBLED IF VIOLATION OCCURRED IN A CONSTRUCTION ZONE WHILE WORKERS PRESENT.**

**The following offenses may be dismissed if requirements are met and dismissal fees paid.**

1. Insurance – Show proof of Insurance for the date of the offense within twenty (20) days of ticket date (No dismissal fee required).
2. Registration – Show proof or Registration with penalty paid at the time of renewal with \$20.00 dismissal fee within twenty (20) days of ticket date.
3. No Motor Vehicle Inspection – Show proof of Inspection with \$20.00 dismissal fee within twenty (20) days of ticket date.
4. Expired Driver's License – Show proof of Valid Driver's License with \$20.00 dismissal fee within twenty (20) days of ticket date.

## REQUEST FOR DRIVER SAFETY COURSE

If you are requesting a Driver Safety Course you will need to contact the Court to determine if your charge can be dismissed upon completing a driver safety course. **If you hold a CDL license or you are charged with Speeding 25 miles or more over the posted speed you will NOT be eligible to request a Driver Safety Course.** A Driver Safety Course can only be taken once every twelve months for dismissal of a traffic citation.

**Requirements below must be received by Court PRIOR to enrolling in a DRIVER SAFETY COURSE AND Request must be NOTARIZED.**

**You must submit your requirements to the Court ON or BEFORE your appearance date located in the BOTTOM right corner of citation.**

1. Pay the NON-REFUNDABLE administration fee in the amount of **\$109.00. \*\*PAY TO THE COURT NOT ONLINE\*\***
2. Furnish the Court with a copy of a valid **Texas Driver's License.**
3. Furnish the Court with a copy of valid **Liability Insurance.**
4. Furnish **Driving Record** from Texas Department of Public Safety. (**www.texas.gov**) (**type 3A**)

I understand that I have ninety (90) days from the citation date to complete my course, if not completed my case will not be dismissed, the fees will not be refunded and the full amount of the fine assessed will be due. If not paid, a warrant may be issued and additional fees may be added.
