3. **Expired Driver's License** — Provide proof of valid Driver's License within 20 days of receiving citation. **Dismissal fee of \$20.00** required. Must contact Court on or before appearance date.
4. **Defective Equipment** — Provide proof that the defect was corrected (receipt, photo, etc.) **Dismissal fee of \$20.00**

1. The payment must be made immediately equal to the current balance of the case plus the **\$75.00 Deferral Fee** as well as collection, warrant and/or driver license fees, if applicable. **You cannot pay online and must send a cashier's check or money order and this Plea Form.**

2. Possess and maintain a current valid driver license or permit during the deferral period (**send copy with this request**). The court may request proof of license status.

3. Commit no moving traffic violation within the city limits of the City of Cumby, Texas."
